

**TOWN OF MCADENVILLE COUNCIL AGENDA

- 1. CALL TO ORDER, PLEDGE OF ALLEGIANCE & INVOCATION**
- 2. ADJUSTMENT & APPROVAL OF JUNE AGENDA:** Items will only be added or removed upon approval of the Mayor and Town Council.
- 3. CONSENT AGENDA:** The items of the “Consent Agenda” are adopted on a single motion and vote, unless the Mayor or Council wishes to withdraw an item for separate vote and/or discussion:
 - a) **Budget Amendment Ordinance #2021-003:** Ordinance authorizing the final amendments to the Budget for Fiscal Year beginning July 1, 2020. The amendments will result in a \$10,250.00 increase in the net appropriations for the General fund and will not affect the net appropriations of the Water/Sewer fund.
 - b) **Approval of Minutes:** Regular Meeting of May 11, 2021, and the Special Meeting/Budget Workshop minutes of May 4, 2021, and May 19, 2021.
 - c) **Interlocal Agreement for Collection of Taxes:** Gaston County has revised the service fees charged to municipalities for distributing tax bills, collecting payments, and processing payments beginning July 1, 2021. A revised interlocal agreement with the new fee schedule is being presented for consideration. Approval is recommended.
 - d) **Resolution #2021-004 Accepting American Rescue Plan Act Grant Funds:** The American Rescue Plan Act (ARPA) was signed into law on March 11, 2021, to assist with speeding up the recovery from the economic and health effects from the COVID-19 pandemic. The Town of McAdenville authorizes the acceptance of these funds and agrees to comply with all law, rules, and regulations, mandated with their acceptance.
 - e) **Resolution #2021-005 Supporting the LYNX Silver Line Extension into Gaston County:** Support for Gaston County to work with the City of Charlotte, CATS, and the Metropolitan Transit Commission to secure sufficient federal funds to complete the extension of the LYNX silver Line into Gaston County.
- 4. BUDGET PRESENTATION – FY21-22:** Staff will present a slide presentation on the estimated revenue and expenditures for the General and Water/Sewer funds highlighting major changes and planned CIP projects.
- 5. PUBLIC HEARING FOR PROPOSED 2021-2022 BUDGET:** This is the required Public Hearing on the proposed budget for the fiscal year beginning July 1, 2021.

- 6. ADOPTION OF BUDGET ORDINANCE #2021-004 FOR FISCAL YEAR 2021-2022:**
The total for the Proposed Budget for the Town of McAdenville for Fiscal Year 2021-2022 is \$1,946,076 with no change to the ad valorem tax rate of .33 cents per \$100 assessed valuation.
- 7. ADOPTION OF WATER/SEWER RATES AND FEE SCHEDULE FOR FY 2020-2021:** A copy of the Water & Sewer Rates and Fee Schedule are included as part of the FY2021-22 Proposed Budget. The Water & Sewer Rates are being increased by 8.5% to offset the wholesale rate increase implemented by the City of Gastonia and fund capital improvements.
- 8. ADOPTION OF GRANT ORDINANCE #2021-005 FOR AMERICAN RESCUE PLAN ACT:** The American Rescue Plan provides funding aid for local governments to respond to public health emergencies with respect to COVID-19, provide premium pay to essential workers, and investment in water and sewer infrastructure; and provides for the provision of government services that can include maintaining of infrastructure including roads and the provision of police, fire, and other public safety services. Grant funding for the Town of McAdenville is anticipated to be \$200,000. A Special Revenue Fund has been created with expected expenditures for utility infrastructure improvements.
- 9. POLICE DEPARTMENT REPORT:** Chief Adams, CPD, will report on police activity for the month of May and address any concerns of Council.
- 10. COUNCIL GENERAL DISCUSSION:** This is an opportunity for the Mayor and Council to ask questions for clarification, provide information to staff, or place an item on a future agenda.
- 11. OPPORTUNITY FOR PUBLIC COMMENT:** This is an opportunity for members of the public to address items of interest to the Mayor and Town Council. This is not a time to respond or act. Any necessary action will be taken under advisement. Speakers are asked to stand, state their name and address for the record and limit comments to no more than five minutes.
